Comprehensive Countywide Mosquito Abatement Services for the 2026 Season

The County Commissioners reserve the right to reject all bids, non-responsive bids, bids of non-responsible bidders, or to accept in whole or part such a bid or bids as may be deemed in the best interest of the County. The County retains the right to have a sixty (60) day award period after the bid opening in order to evaluate other public entity bids.

Individuals who need accessible communication or other accommodations in order to participate in this bid are invited to make their needs and preferences known to the ADA/504 Compliance Coordinator, Laraine Pope, Bingham County Human Resource, at least 3 to 5 days in advance of the bid opening.

Bidders shall submit their bids to on the county form supplied by Bingham County. No Bid Bond is required for the bid opening.

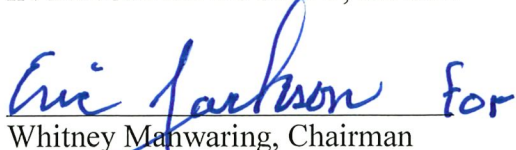

SPECIFICATIONS FOR MOSQUITO ABATEMENT SERVICES

GENERAL SERVICES

The work shall include, but not be limited to:

- Larval mosquito surveillance with GPS mapping and setting up and maintaining a data base of sites, which include but are not limited to: permanent water sites, temporary water sites, artificial containers, catch basins, septic water habitats.
- Adult mosquito surveillance including CDC miniature light traps, gravid traps and landing rate counts.
- Aerial and ground larviciding and aducliding applications which include, but is not limited to: granular and liquid BTI applications, granular and briquette Methoprene, pupacide, aerial larviciding operations via drone using licensed FAA Part 137 drone operators, truck ULV applications, service requests from the public, receiving and responding to nuisance mosquito problems using education using trade techniques.
- Disease monitoring including West Nile Virus (WNV) testing, rapid response to outbreaks, and coordination with public health agencies and routine progress reporting of all program activities.
- Rapid response to outbreak WNV via drone and ground coverage.
- Public education through presentations, brochures, and community outreach.
- Recordkeeping and reporting of regulations and maintain records of all operations of inspection and applications, all of which to be tabulated and presented in a written monthly report to the District.
- Integrate all GPS and GIS data into easy read maps and reports.
- Fulfill all EPA NPDES, Pesticide General Permit requirements and obligations, including Pesticide Discharge Management Plan development and implementation and annual reporting.
- Answer all service requests and questions within 24 hours.
- Comprehensive insurance policy.

CONTRACTOR QUALIFICATIONS

Contractor shall meet or exceed the following minimum qualifications:

- Management team with at least 10 years of direct mosquito abatement experience within Idaho.
- Proven experience conducting county-wide mosquito control programs.
- Demonstrated history working with local abatement district boards and health departments.
- Maintenance of FAA Part 137 certification for drone operations.
- All aerial operations must be conducted by in-house licensed operators.

BID SECURITY

Each bid shall be accompanied by a bid bond or certified check equal to five percent (5%) of the total bid amount, payable to Bingham County, per Idaho Code § 67-2806(2)(b).

AWARD OF CONTRACT

The County reserves the right to reject any or all bids, to waive informalities, and to accept the bid deemed most advantageous and in the best interest of Bingham County.

The lowest product price may not be the lowest cost to the county; the decision will be made by using the lowest overall cost.
