BINGHAM COUNTY'S INITIATION OF COMPREHENSIVE PLAN MAP AREA AMENDMENT FOR PARCELS LOCATED IN THE RIVERTON AREA OF BLACKFOOT, IDAHO (ACTION: DECISION) The Board of County Commissioners will hold a Public Hearing to receive the Planning & Zoning Commission's recommendation to deny an amendment to the Comprehensive Plan Map Area designation from Residential/Agricultural to Agricultural. According to the Planning and Zoning Commission's action on March 19, 2025, AND PER Bingham County Code Title 10 Chapter 15 Amendments, Bingham County Code Section 10-3-6, and Idaho Code 67-6509, the following parcels of land located in the Riverton area of Blackfoot, Idaho have a Bingham County Comprehensive Plan Map Area designation of Residential/Agricultural and a Zoning Designation of Agriculture.
