BINGHAM COUNTY AMENDED RESOLUTION 2025-15

A RESOLUTION REPEALING A PORTION OF THE BINGHAM COUNTY ROAD STANDARDS AND AMENDING THE BINGHAM COUNTY ROAD STANDARDS MANUAL FOR USE BY THE BINGHAM COUNTY PUBLIC WORKS DEPARTMENT

WHEREAS the Bingham County Board of Commissioners have reviewed concerns that the Public Works Director presented in utilizing the Bingham County Road Standards Manual and found that it is in the best interest of the county to repeal subsections in said manual regarding the illustrations, wording and documents of cluster mailbox systems;

Be it ordained by the Board of County Commissioners of Bingham County, Idaho:

- Bingham County Resolution 2024-17 The current Road Standards Manual being used by the Bingham County Public Works Department provided by Bingham County, will have the following repealed;
 - a. Section III Design Criteria, O- Right-of-ways, All Subdivisions, Design and Maintenance – Figure 8 – Cluster Mailbox Detailed Illustration
 - b. Section II Definition of Terms Cluster Mailbox System
 - Section III Design Criteria, O- Right of Ways, all Subdivisions, Design and Maintenance – 4. Cluster Mailbox systems.

WHEREAS the Bingham County Roads standards Manual being used by the Bingham County Public Works Department will have amendments to Section 3, Subsection O, which will read as follows;

Be it ordained by the Board of County Commissioners of Bingham County, Idaho:

- 2. The current Road Standards Manual being used by the Bingham County Public Works Department provided by Bingham County, will have amendments to the following;
 - a. Section III Design Criteria, O- Right-of-ways, All Subdivisions, Design and Maintenance –

- 4. Mailboxes within a subdivision shall be placed completely out of the lane of traffic of any county road. All Mailbox Structures and their locations must be approved by the local U.S. Post Master, in writing, and placed in accordance with the county approved mailbox turnout. Refer to Bingham County Standard Construction Plans for Mailbox Turnout diagram (Figure 7 page 24).
- 3. Said Amendments can be viewed at the Bingham County Public Works Department or on the Bingham County Website.

NOW, THEREFORE, BE IT RESOLVED, BY THE Board of County Commissioners of Bingham County, Idaho that the aforementioned areas of the current road standards and Bingham County Resolution 2024-17 be Resolved and Repealed and that the aforementioned amendments be implemented:

Pursuant to discussions held on December 4, 2024 and per Bingham County Ordinance 2025-02, adopted on February 12, 2025, the above changes will be in effect as of February 12, 2025.
