


BINGHAM COUNTY

A RESOLUTION CHANGING THE FEES FOR THE BINGHAM SOLID WASTE DEPARTMENT, BINGHAM COUNTY COMMISSIONERS FEES, BINGHAM COUNTY PROBATION FEES EFFECTIVE IMMEDIATELY, BINGHAM COUNTY ASSESSORS OFFICE AND BINGHAM COUNTY PLANNING & ZONING FEES EFFECTIVE AS OF JANUARY 1, 2021 FOR BINGHAM COUNTY.


Whereas, the Bingham County Commissioners met on the 15th day of December, 2020, and approved the following fees provided by the Bingham County Solid Waste Department, the Bingham County Probation Department, the Bingham County Assessor's Office, the Bingham County Planning and Zoning Department and the Bingham County Commissioners, pursuant to Idaho Code §63-1311A.

Be it hereby resolved that the fee change for the Bingham County Solid Waste Department, the Bingham County Probation Department and Bingham County Commissioners and are attached as Exhibit A-C, which will be effective immediately. The fees for the Bingham County Planning & Zoning Department and the Bingham County Assessor's Office are attached as Exhibit D will be effective January 1, 2021. All previous fee schedules for these departments are repealed as of the effective dates.





The Fee Scheduled listed below covers all fees associated with Bingham County Juvenile Probation and Bingham County Misdemeanor Probation Services. Most of the fees included below are ordered by the Courts or are established by Idaho Code. Other fees listed are intended to help cover the cost of the services being provided. This Fee Schedule will be in effect immediately upon approval from the Bingham County Board of County Commissioners.

All of the fees associated with sending samples to Redwood Toxicology Laboratories are based on the cost of the process being requested plus additional cost for staff time to prepare the sample for shipping, materials involved in the shipping and the cost of the shipping itself. This increase is approximately \$5 added on to the Redwood charge. The cost is approximate because we rounded up to the next increment of 5. For example, if the cost to send a sample to Redwood for confirmation is \$10, then we have increased this fee to \$15 to cover the additional costs mentioned above.




